Eligibility & Agreement

Michigan artists 16 years of age and older may enter. Entries can be in any medium, and all entries must be original works of the artist's own creation, and have been completed in the last 5 years. Artwork from previous GACA shows will not be accepted. GACA reserves the right to reject any work that cannot be properly displayed because of size, fragility, or any other reason that hinders proper display.

Sending an entry into the GACA 2013 Juried Fine Art Exhibit constitutes agreement by the artist to the conditions and requirements of the show as stated in this Call to Entry, and the following: GACA reserves the right to reproduce accepted entries for publicity or archival purposes; the Juror reserves the right to reject any submissions; award decisions of the Juror are final; all accepted works will remain as placed for exhibition by the Visual Arts Committee

Sales, Conditions & Fees

The artist agrees to leave accepted entries on display at the GACA Arts Center for the full duration of the exhibition. If an accepted work is sold during the exhibition, GACA will retain a 25% commission on all sales.

An individual artist may submit up to (4) works for a non-refundable fee of \$20 for GACA members, or \$30 for nonmembers. Paintings and drawings must be framed and wired for hanging at the time of submission. 3-D art will also be accepted for judging. Photography will not be accepted. Clearly print the following on the back of submitted pieces or in an inconspicuous spot on 3-D art: Artist's Name, Title of Work, Medium, and Size in inches. A self addressed, stamped envelope must accompany all submissions so that the completed Juror form can be returned to the artist following the judging. All entries must be delivered to the GACA Community Arts Center no later than 1pm on Friday Sept. 6th, 2013.
