### Submission Procedure

Up to three (3) images may be submitted. Images must be emailed (.jpg format). Image size approximately 1200 x 1800 pixels at 300 ppi. Image files named as follows: lastname\_firstname\_title of entry  
Entries submitted by **email by** Jan. 12 to: gacaexhibits@gmail.com  
(This above **email address is for exhibit entries only**)

Entry form and fee must be received in the GACA office by no later than Jan. 12th (mailed or hand delivered), in order for the images to be eligible for judging.

Payment may be made by cash, check or money order. Credit cards in person, only. **\$20 for GACA members—\$30 for non-members.**  
Artists will be notified by email regarding accepted images by Jan. 26th.  
Accepted entries—framed, wired and ready to hang—must be delivered to GACA from February 26 to March 1.

Clearly print on the back of each accepted piece: Photographer's Name, Title of Work and Selling Price. If not for sale - "For Exhibit Only".  
Exhibit opens March 9th - Reception and Awards Ceremony from 5-7 p.m.  
**Exhibit closes April 30, 2012**

Michigan photographers 16 years of age and older may enter. Photographers with seasonal homes in Michigan may also enter. Any work dependent primarily on the photographic process is acceptable. All entries must be original works of the artist's own creation and cannot have been taken more than five years ago. Works from previous GACA juried shows will not be accepted. GACA reserves the right to reject any work that they do not wish to display because of size, fragility or for any other reason.

## Sales

**GACA will retain a 25% commission on all sales of works sold during the exhibit.**

## Agreement

Sending an entry into the GACA 2013 Juried Photography Exhibit constitutes agreement by the artist to the conditions and requirements of the show as stated in this Call for Entries and the following: GACA reserves the right to reproduce accepted entries for publicity purposes only. The Juror reserves the right to accept or reject any submission and award decisions of the Juror are final. All accepted works will remain as placed for the exhibit by GACA. 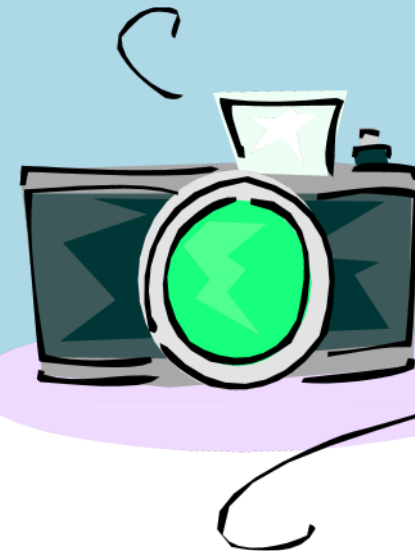
